### INDEPENDENT AUDITOR'S REPORT

To the Unitholders of Stanbic IBTC Ethical Fund

### Report on the Audit of the Financial Statements

Opinion
We have audited the financial statements of Stanbic IBTC Ethical Fund ("the Fund"), which comprise:

- the statement of financial position as at 31 December, 2020;
   the statement of comprehensive income;
   the statement of changes in net assets attributable to unitholders;
   the statement of cash flows for the year then ended; and
   the notes, comprising significant accounting policies and other explanatory information.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Fund as at 31 December, 2020, and of its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs) and in the manner required by the Financial Reporting Council of Nilgeria Act, 2011.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs).
